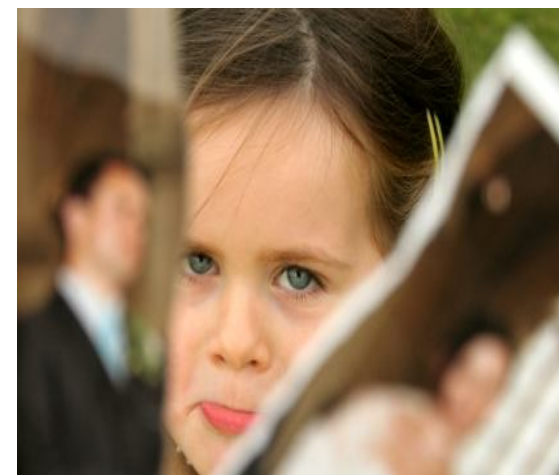

SHARED PARENTING

House Bill 463

Rebuttable Presumption of Joint Custody

This would require a judge to consider joint physical care as the first option for a parenting schedule. This means children will have equal time with both parents in the event of a separation or divorce.

Removes the child as a weapon in custody and divorce.

Children are less likely to suffer from physical, emotional, or sexual abuse.

The cost and time of litigation would be much lower, less frequent, or non-existent.



Did You Know...

It is no coincidence that the least stable parent (in terms of job, finances, housing, etc.) will more likely get primary custody because that gives the greatest chance to the local government to collect additional federal funds (from taxpayers) as a result of child support collection, cash assistance, child care assistance and a host of other programs funded in this manner.



Divorce and child custody issues are a main source of revenue for state and local government. The "best interest of the child" standard, is non-measurable and different from judge to judge.

Our Belief

Every child has the right to be guided, nurtured and supported emotionally, physically, and financially by both parents.

We believe equal, shared parenting time or joint custody is the optimal best interest of the child. We believe when parents are given equal rights, equal responsibility follows; when parents have equal access to their children and support levels are reasonable and reflect the true cost of raising a child, parents will comply with court orders. When equality is created in our laws, the conflict inherent in divorce situations dissolve.

Virtually every major social pathology, from violent crime to drug abuse is directly attributable to family breakdown and the lack of both parents equal involvement. This fills state and local government coffers with federal money for all kinds of social programs to help solve these divorce-related social problems.

Many legislators avoid the subject or support of joint custody citing domestic and child abuse myths.
